IOWA FINANCIAL INCENTIVE PROGRAM FOR SOIL EROSION CONTROL
AMENDMENT TO MAINTENANCE AGREEMENT

Iowa Department of Agriculture and Land Stewardship
Division of Soil Conservation
Madison County Soil and Water Conservation District

THIS AGREEMENT is made and entered into this 3rd day of January, 1995,
by and between Madison County Soil and Water Conservation District,
herein called DISTRICT, and Gayla Mills herein called RECIPIENT.

The parties of this agreement, DISTRICT and RECIPIENT, hereby agree to amend the
Maintenance Agreement previously executed between the DISTRICT and RECIPIENT of
cost-share funds. The Maintenance Agreement is amended as follows:

TO: Maintain the tree planting as it is without planting additional trees. Maintenance will be achieved by
locating and flagging either during the winter of 1994/95 when the snow has packed down the grass around the
trees or in September-October, 1995, while the trees still have their autumn leaves.

After flagging;
Spot spraying will be done with a backpack sprayer to produce a 4 foot diameter circle around each tree
with a mixture of 2 lbs. active ingredient per acre treated of Kerb, 4lbs. a.i./acre Princep, and
2 lbs. a.i./acre of either Surflan or Pendulum. This application is to be done in the Fall, 1995, after soil
temperatures have dropped to 50 degrees or less (early to mid November, 1995).
