

RESOLUTION

WHEREAS, Doyle R. Mapes, Christine A. Mapes, Richard J. Johnson, A. Irlene Johnson, Richard E. Johnson, Vickie C. Adams, Carl Tessmer, Sara L. Tessmer and Union State Bank have filed a Proposal to Create Agricultural Area, pursuant to Iowa Code Section 352.6; and

WHEREAS, the Madison County Board of Supervisors have held a hearing as required by Iowa Code Section 352.7.

NOW, THEREFORE, BE IT RESOLVED by the Madison County Board of Supervisors as follows:

1. The following described real estate is hereby established as an agricultural area:

Tract 1: NE SE of 19-77-28; NW SE except parcel A 4.06A of 17-77-28; SW SE of 19-77-28; and SE SE of 19-77-28, west of the 5th P.M. Madison County, Iowa.

Tract 2: NE NE of 30-77-28; NW NE of 30-77-28; SW NE of 30-77-28; SE NE except 3.06A. of E 1/4 of 30-77-28; NE SE except 19.72A. of South half of 30-77-28; and NW SE except 26.65A. South half of 30-77-28, west of the 5th P.M. Madison County, Iowa.

Tract 3: SW NE of 29-77-28; NW NE of 29-77-28; NE NE of 29-77-28; SE NW of 29-77-28; SW NW of 29-77-28; SE NE of 29-77-28; NE SE of 29-77-28; NW SW of 29-77-28; and NE SW of 29-77-28, west of the 5th P.M. Madison County, Iowa.

Tract 4: SE SE of 29-77-28; and SW SE of 29-77-28, west of the 5th P.M., Madison County, Ia.

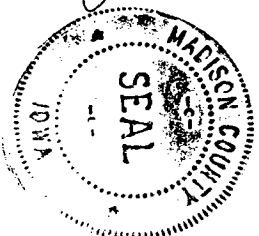
Tract 5: SE NW of 28-77-28; SW NW of 28-77-28; NW NW of 28-77-28; 2.7A NE part of NE NW of 28-77-28; NE NW except 2.7A NE part of 28-77-28; 4.A NW part NW NE of 28-77-28; NW NE except 4.A NW part of 28-77-28; and SE SW of 21-77-28, west of the 5th p.m. Madison County, Iowa.
