If the space provided for any item is inadequate, the item should be continued on additional sheets. Use of additional sheets or a non-standard form requires an additional fee of \$1.00. This UCC-4 must be signed by the secured party of record.
3. In addition to the filing fee for fixture filings (in County Real Estate Records), there will be a fee of \$3.00 per page for recording and a fee of \$3.00 per page for a partial release or termination of the fixture filing.
4. This form shall be filed and recorded in county real estate records under a real estate number. This form also shall be indexed under a real estate number in the UCC files in a County Recorder's office.
