



Parcel "B" in the Northeast Quarter of the Southeast Quarter of Section 22, Township 76 North, Range 28 West of the 5th P.M., Madison County, Iowa more particularly described as follows:

Beginning at the East Quarter Corner of Section 22, Township 76 North, Range 28 West of the 5th P.M., Madison County, Iowa thence South 00°02'30" East256.24 feet along the East line of the Southeast Quarter of said Section 22; thence North 86°47'38" West 550.00 feet; thence North 00°02'30" West 226.80 feet to a point on the North line of the Southeast Quarter of said Section 22; thence South 89°51'45" East 549.12 feet to the Point of Beginning containing 3.04 acres including 0.58 acres of County Road right-of-way.

Beginning at the East Quarter Corner of Section 22, Township 76 North, Range 28 West of the 5th PM, Madison County, Iowa thence South 00°02′30″ East 256.24 feet along the East line of the Southeast Quarter of said Section 22; thence North 86°47′38″ West 550.00 feet; thence North 00°02′30″ West 226.80 feet to a point on the North line of the Southeast Quarter of said Section 22; thence South 89°51′45″ East 549.12 feet to the Point of Beginning containing 3.04 acres including 0.58 acres of County Road right-of-way.

- 3. The Zoning Administrator of the City of Winterset, Madison County, Iowa, is hereby directed to certify this resolution which shall be affixed to said plat to the County documents which should be filed and recorded in connection therewith.
