## AFFIDAVIT - NOTICE OF NAME CHANGES - FLCA/PCA

I, Carla H. Timm, Corporate Secretary of Farm Credit Services of the Midlands, FLCA, and Corporate Secretary of Farm Credit Services of the Midlands, PCA, both federally chartered instrumentalities and corporations organized and existing under the laws of the United States of America, do hereby on oath depose and certify that:

Pursuant to Section 7.6 of the Farm Credit Act of 1971, as amended, and the Farm Credit Administration Regulations, the Boards of Directors and the voting stockholders of Farm Credit Bank of Omaha (FCB) and of Federal Land Bank Association of the Midlands (FLBA) approved an Agreement and Plan of Transfer.

Article I, Section 1.1(b) of the Agreement and Plan of Transfer provides:

"The FCB loans that were serviced by the FLBA prior to the Effective Date will continue to be serviced by the FLCA."

Article I, Section 1.1(f) of the Agreement and Plan of Transfer provides:

\*On the Effective Date, the FLBA's name shall become Farm Credit Services of the Midlands, FLCA, with its headquarters at 206 South 19th Street, Omaha, NE.\*

The Agreement and Plan of Transfer was approved by the Farm Credit Administration effective at the close of business September 30, 1993.

Farm Credit Services of the Midlands, FLCA is successor in interest to Federal Land Bank Association of the Midlands. The territory served by Farm Credit Services of the Midlands, FLCA is the same territory as served by Federal Land Bank Association of the Midlands, namely the states of lowa, Nebraska, South Dakota, and Wyoming; the Farm Credit Administration has amended the charter accordingly.

Further, on April 27, 1993, the Board of Directors of Production Credit Association of the Midlands passed a resolution to request the Farm Credit Administration to amend the charter of Production Credit Association of the Midlands only to change the name from Production Credit Association of the Midlands to Farm Credit Services of the Midlands, PCA. The Farm Credit Administration approved this request effective at the close of business September 30, 1993.

Farm Credit Services of the Midlands, PCA is successor in interest to Production Credit Association of the Midlands. The territory served by Farm Credit Services of the Midlands, PCA is the same territory as served by Production Credit Association of the Midlands, namely the states of lowa, Nebraska, South Dakota, and Wyoming; the Farm Credit Administration has amended the charter accordingly.
