POWER OF ATTORNEY - CONTINUATION OF POWERS OF ATTORNEY

Farm Credit Bank of Omaha, a federally chartered instrumentality and corporation organized and existing under the laws of the United States of America, and having its principal place of business at 206 South 19th Street, Omaha, Douglas County, Nebraska, 68102, does hereby state that:

Pursuant to Section 7.6 of the Farm Credit Act of 1971, as amended, and the Farm Credit Administration Regulations, the Boards of Directors and the voting stockholders of Farm Credit Bank of Omaha (FCB) and of Federal Land Bank Association of the Midlands (FLBA) approved an Agreement and Plan of Transfer.

Article I, Section 1.1(b) of the Agreement and Plan of Transfer provides:

"The FCB loans that were serviced by the FLBA prior to the Effective Date will continue to be serviced by the FLCA."

Article I, Section 1.1(f) of the Agreement and Plan of Transfer provides:

"On the Effective Date, the FLBA's name shall become Farm Credit Services of the Midlands, FLCA, with its headquarters at 206 South 19th Street, Omaha, NE."

Effective at the close of business September 30, 1993, Farm Credit Services of the Midlands, FLCA, successor in interest to Federal Land Bank Association of the Midlands, shall succeed to and possess all powers and authorities previously granted to the Federal Land Bank Association of the Midlands pursuant to the Powers of Attorney dated December 22, 1976, September 25, 1987, and February 17, 1989, and recorded in each county of the states of lowa, Nebraska, South Dakota and Wyoming, all terms of which are incorporated herein by reference and made a part hereof.

Farm Credit Services of the Midlands, FLCA, as Agent and Attorney-in-Fact on behalf of Farm Credit Bank of Omaha, is authorized to perform all acts and to execute all documents as set out in said Powers of Attorney on behalf of Farm Credit Bank of Omaha under the seal of the Farm Credit Services of the Midlands, FLCA.

The attestation of documents by the Secretary, or any Assistant Secretary of Farm Credit Services of the Midlands, FLCA is permitted, but not necessary, and any attesting signatures need not be acknowledged.

This Power of Attorney shall remain in full force and effect until revoked in writing and recorded in the offices where the original Powers of Attorney and this Power are filed or recorded.

It is intended that all parties may rely upon any action undertaken and any documents executed by, for or on behalf of Farm Credit Bank of Omaha as set forth above, without further inquiry into the power and authority of Farm Credit Services of the Midlands, FLCA.
