We, the undersigned persons, acting as Incorporators of a professional Corporation, organized under the Professional Corporations Act, Chapter 496C, Iowa Code (1989), hereby adopt the following Articles of Incorporation for such professional Corporation:

I. The name of the professional Corporation is Chickering & Janssen, P.C.

II. Corporate existence shall commence 1 Jan 1991 and continue in perpetuity.

III. The Professional Corporation is organized to engage in the general practice of law and to do all lawful things which may be incidental to, necessary or convenient in connection with the practice of the legal profession and any and all lawful business for which Professional Corporations may be incorporated under the Iowa Professional Corporations Act, Chapter 496C, Iowa Code (1989).

IV. The aggregate number of shares which the Professional Corporation has authority to issue is:
