

NOTICE OF PERSONAL PROPERTY TITLE

Know All Men by These Presents: That the undersigned George P. Dickey of Warren County, Iowa do hereby state to any and all men that all personal property (list appended to this document) is owned by myself, Goerge P. Dickey, and my son, George R. Dickey, in full and with all rights of title. I further state that all such personal property has been stored in my house in Truro, Madison County, Iowa, legally described as:

Lots One (1) and Two (2) in Block Seven (7) of the Original Town of Truro (formerly called Ego), Madison County, Iowa.

I also further state that the title to said real estate was converted to Lois M. Witt, my sister, on October 4, 1990. Further real estate transfer did not include ANY personal property of mine or my son's.

I state that title to personal property would have been retained by me and my son George R. Dickey, as any reasonable person would assume, and would not have been converted to my sister Lois M. Witt or any other person by virtue of the said real estate conversion or by my Power of Attorney, then held by my sister Lois M. Witt.

I affirm that all items I owned were to have been held in trust by Lois M. Witt during the length of the Power of Attorney; said trust would assume proper and adequate care of the personal property. I affirm that my son George R. Dickey, previous to Lois M. Witt's holding of my Power of Attorney, did act as my Power of Attorney and retained the personal property and real estate in Truro in good condition until passage of Power of Attorney to Lois M. Witt.

I affirm that all items contained listed in the addendum were stored at said property location on premises in good condition at the time of change of Power of Attorney from my son George R. Dickey to my sister Lois M. Witt.

I direct Lois M. Witt to recover, restore, and return all personal property items to my son Goerge R. Dickey immediately.

I give and grant unto my son George R. Dickey full ownership of all items left on and in the premises of said real estate property at the time of the transfer of Power of Attorney from him to Lois M. Witt forward; said full ownership includes any disposition that he may desire; said full ownership authorizes my son George R. Dickey the full power and authority to do and perform any other ownership functions without any limit regarding all items so described in the addendum.

Words and phrases herein, including acknowledgment hereof, shall be construed as in the singular or plural number, and as masculine or feminine gender, according to the context.

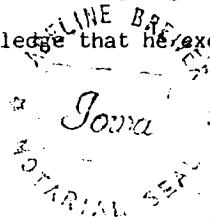
