This AGREEMENT is made and entered into this 22 day of January, 19 91, by and between

Madison County Soil Conservation District, herein called DISTRICT,

and W. Dean Moore, herein called RECIPIENT.

The parties of this AGREEMENT, DISTRICT and RECIPIENT, hereby agree to amend the Maintenance Agreement previously executed between the DISTRICT and the RECIPIENT of financial incentive funds. The Maintenance Agreement is amended as follows:

The legal description of the property on which the terraces were built was incorrect.

The correct legal description is as follows:

E 1/2 SW 1/4 Section 14 Lincoln Twp. T75N/R28W

The following tract of land should be released from any maintenance agreement:

The Southeast Quarter (1/4) of the Southeast Quarter (1/4) of the Southeast Quarter (1/4) of Section Ten (10), and the Northeast Quarter (1/4) of the Northeast Quarter (1/4) of Section Fifteen (15), and the Northwest Quarter (1/4) of the Northwest Quarter (1/4) of Section Fourteen (14), and all that part of the following described tract of land lying North of Middle River, to-wit: Commencing at the Northwest corner of the Northeast Quarter (1/4) of the Northwest Quarter (1/4) of said Section Fourteen (14) and running thence East 30 rods, thence South 46 rods, thence West 30 rods, thence North 46 rods to the place of beginning; all in Township Seventy-five (75) North, Range Twenty-eight (28) West of the 5th P.M., Madison County, Iowa.

The parties of this AGREEMENT, DISTRICT and RECIPIENT, agree that all provisions and conditions of the Maintenance Agreement and previous amendments thereto shall remain in full force and effect, except for those changes made by this AGREEMENT. DISTRICT and RECIPIENT also agree that this amendment shall be effective on the date of the last signature hereto.
