That I, the undersigned, have formed a body corporate under the laws of the State of Iowa, and to that end have adopted the following Articles of Incorporation.

REGISTERED OFFICE AND REGISTERED AGENT


The registered office of this corporation shall be located at R.R. 1, Peru, Iowa 50222, and the initial registered agent at such address shall be Willard C. Fox.
