

We note that the popular names of these branches will be Waterloo Office, Cedar Falls Office, Cedar Falls Kimball Office, Dunkerton Office, La Porte Office, Parkersburg Office, and Parkersburg Drive-in, respectively.

This letter is also the official OCC certification of the approval of the Comptroller of the Currency given to Norwest Bank Iowa, National Association to increase its common stock to \$33,700,000 as of June 17, 1991.
