KNOW ALL MEN BY THESE PRESENTS:

I have formed a corporation under the laws of the State of Iowa, and as incorporator, I have adopted the following Articles of Incorporation.

ARTICLE I

NAME

The name of this corporation is "Des Moines Transportation Co."

ARTICLE II

STATUTE

This corporation is organized under the provisions of Chapter 490 of the Code of Iowa.

ARTICLE III

SHARES

This corporation shall have authority to issue 100 shares of capital stock of one class, common, with each share having a par value of \$100.00. This class of shares shall have unlimited voting rights. The owners of these shares, upon dissolution, shall be entitled to receive the net assets of the corporation.

ARTICLE IV

REGISTERED OFFICE AND REGISTERED AGENT

INCORPORATOR

ARTICLE VII

RESTRICTION AND TRANSFER OF SHARES


Restrictions on the transfer of common stock in the corporation, if any, shall be set forth in the By-laws, and noted on the front or back of each share certificate.

ARTICLE VIII

SEAL

This corporation shall have no corporate seal.



