

DISCHARGE OF DEBTOR, NOTICE OF HEARING ON
DISCHARGE, AND REAFFIRMATION OF DEBT

It appearing that all persons named in the caption hereof filed petitions commencing cases under Title 11, United States Code; that orders for relief were entered under Chapter 7 and that no complaints objecting to the discharge of the debtors were filed within the time fixed by the court.

It is, ORDERED, that,

1. The above-named debtors are released from all dischargeable debts.

2. Any judgment heretofore or hereafter obtained in any court other than this court is null and void as a determination of the personal liability of the debtors with respect to any of the following:

- (a) debts dischargeable under 11 U.S.C. § 523;
- (b) unless heretofore or hereafter determined by order of this court to be nondischargeable, debts alleged to be excepted from discharge under clauses (2), (4), and (6) of 11 U.S.C. § 523(a).
- (c) debts determined by this court to be discharged.

3. All creditors whose debts are discharged by this order and all creditors whose judgments are declared null and void by paragraph 2 above be and they are hereby enjoined from commencing, continuing, or employing any action, process, or act to collect, recover, or offset any such debt as personal liability of a debtor, or from property of a debtor, whether or not discharge of such debt is waived.

It is further, ORDERED, and the debtor is hereby notified that pursuant to 11 U.S.C. § 524(d) a discharge hearing will be held for the debtors named above on the 27th day of February, 1987, in the U. S. Bankruptcy Court Room, 314 U. S. Court House, E. 1st and Walnut Streets, Des Moines, Iowa, at 1:00 o'clock p.m.


