RESTATED ARTICLES OF INCORPORATION

TO THE SECRETARY OF STATE:

Pursuant to the provisions of Section 39 of the Iowa Nonprofit Corporation Act, the undersigned Corporation adopted the following Restated Articles of Incorporation:

I. The name of the corporation is EARLHAM COMMUNITY PROJECTS COMMITTEE, INCORPORATED.

II. The period of its duration is perpetual.

III. The corporation is organized exclusively for charitable and educational purposes. The general object of this corporation is to promote activities which foster educational and charitable activities of its members and the residents of the Community of Earlham, Iowa, and to engage in such activities as shall foster civic pride and community welfare of the Community of Earlham, Iowa.




