Pursuant to the Financial Institutions Reform, Recovery, and Enforcement Act of 1989 ("FIRREA"), the FSLIC was abolished as of the date of enactment of the FIRREA, and the Resolution Trust Corporation ("RTC") was created. By Resolutions issued by the Boards of Directors of the FDIC and the RTC, dated as of August 9, 1989, the RTC and the FDIC agreed that the RTC would succeed to and assume the rights and obligations of FSLIC under the Management Agreement. The rights and obligations of both parties continue in full force and effect until terminated by mutual agreement of their respective Boards of Directors.

That by Resolution issued under delegated authority of the Director of the Office of Thrift Supervision ("OTS") dated as , 1990, the RTC was appointed receiver of of February 9 American Federal Savings and Loan Association of Iowa

formerly savings association, having its principal place of business in Iowa was declared insolvent and closed by Resolution of the Director of OTS dated <u>February 9</u>, <u>1990</u>, ("Receivership"). The Federal Deposit Insurance Corporation as Manager for the receiver has determined that it is necessary to appoint a representative to act on its behalf in connection with the liquidation of the Receivership.
