## ARTICLE I. IDENTIFICATION OF PARTIES AND PROJECTS

This Agreement is entered into by and between the Iowa Department of Human Services and Madison County General Relief, and is intended to implement 1990 Iowa Acts, Senate File 2327, section 17.

## ARTICLE II. DESIGNATION OF OFFICIALS

Marvin A. Weidner, Administrator, Division of Economic Assistance, Department of Human Services, and Chairperson of the Madison County Board of Supervisors, are the officials authorized to execute any changes in the terms of this Agreement.

## ARTICLE III. STATEMENT OF PURPOSE

In accordance with 1990 Iowa Acts, Senate File 2327, section 17, and Iowa Administrative Code, 441--58.4(7), ELIGIBILITY REQUIREMENTS: Application for Other Benefits, the Madison County General Relief Director agrees to accept referrals by the Department of Human Services and process applications for General Relief for individuals who have applied for the Emergency Assistance Program.

The parties to this Agreement agree that the following information may be shared without a signed release from the client for the purposes of determining eligibility for the Emergency Assistance Program:

- A. The Department of Human Services may share the name and address of the Emergency Assistance applicant.

B. The Madison County General Relief Director may share the following information:

- o Date of application for General Relief benefits.
- o An indication of whether the application was approved or denied.
- o If approved, the amount(s) and date(s) of benefits received for each item of assistance.
- o If denied, an indication of whether the denial was due to the client's failure to cooperate with the work and training requirements of the General Relief Program.


Both parties agree that, for the duration of and as a condition of the Agreement, the duty to perform under the terms of this Agreement will be in compliance with all applicable laws and regulations of the State of Iowa and the Federal government, including, but not limited to: confidentiality of records according to the 1989 Iowa Code Section 217.30 and 45 Code of Federal regulations 205.50; Equal Employment Opportunity provisions; Occupational Health and Safety Act; records retention; audit requirements; and other applicable laws, rules, regulations and policy interpretations provided by the Department of Human Services.


Notwithstanding any other provisions of this Agreement, either party may, with thirty (30) days notice, terminate this Agreement.
