Both parties agree that, for the duration of and as a condition of the Agreement, the duty to perform under the terms of this Agreement will be in compliance with all applicable laws and regulations of the State of Iowa and the Federal government, including, but not limited to: confidentiality of records according to the 1989 Iowa Code Section 217.30 and 45 Code of Federal regulations 205.50; Equal Employment Opportunity provisions; Occupational Health and Safety Act; records retention; audit requirements; and other applicable laws, rules, regulations and policy interpretations provided by the Department of Human Services.

Notwithstanding any other provisions of this Agreement, either party may, with thirty (30) days notice, terminate this Agreement.
