DOLLARS (\$ \$500.00) in hand paid, the receipt of which is hereby acknowledged,
Daryl L. Johnson and Linda J. Johnson, husband and wife

hereinafter called Grantors, (whether one or more), do hereby warrant and convey unto Amoco Oil Company,

a Maryland corporation, its successors and assigns, hereinafter called Grantee, the right to construct, install, maintain, inspect, operate, re-
pair, replace, change or remove a cathodic protection unit with any ground beds, anodes, poles, cables, and other material, apparatus, and equipment
used in connection therewith or incident thereto, together with the right to trim or cut trees, if necessary, to prevent interference with the full enjoy-
ment of the use of said cathodic protection unit, on the following described land, of which Grantors warrant they are the owners in Fee Simple,

situated in Madison County, State of Iowa, to-wit:

SE/4 W/2 NE/4 Section 27, Township 75 North, Range 28 West

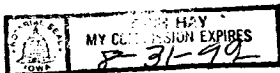
together with the right of ingress and egress to and from said land for the purposes aforesaid.
