ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF MADISON COUNTY ASSOCIATION FOR RETARDED CITIZENS

TO THE SECRETARY OF STATE OF THE STATE OF IOWA:

Pursuant to the provisions of Section 504A.36 of the Iowa Nonprofit Corporation Act the undersigned Madison County Association for Retarded Citizens does hereby state:

This corporation was incorporated under Chapter 504A of the Code of Iowa on September 7, 1966, with the name of Madison County Association for Retarded Children.

At a meeting of the membership, at Winterset, Iowa on October 12, 1987, after due adoption of a Resolution by the Board of Directors, and after due notice, and due receipt of the proposed amendments, in writing, in accordance with the provisions of Chapter 504A of the Code of Iowa and of said Articles, the membership adopted the following amendments by more than a two-thirds affirmative vote of the qualified voters present and constituting a quorum, as follows:

ARTICLE I of said Articles is hereby amended by striking all of said Article and substituting in lieu thereof:

ARTICLE I.

Section 1. The name of this corporation shall be Madison County Association for Special People.

Section II. The term "Special People" as used herein shall include all special people of all ages.

ARTICLE V of said Articles is amended by striking the words "retarded citizens" from the 2nd line of Section E thereof; and inserting in lieu thereof, the words "SPECIAL PEOPLE".

"IT IS HEREBY RESOLVED THAT:

The corporation hereby adopts the foregoing Articles of Amendment to the Articles of Incorporation and the President and Secretary are hereby authorized and directed to sign, acknowledge, record, and do any and all things required by law to execute and carry into effect the Articles of Amendment adopted herein."

(The Articles of Amendment, and the resolution adopting the same, are completely and correctly set forth above and include all of the amendments to said Articles of Incorporation; and they have been duly adopted as required by law and by the provisions of said Articles.)

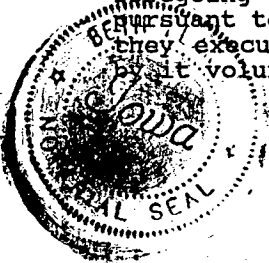
