MINUTES OF A SPECIAL JOINT MEETING OF THE BOARD OF DIRECTORS AND SHAREHOLDERS OF WINTERSET PRINTING AND PUBLISHING, INC.

A special joint meeting of the Board of Directors and Shareholders of Winterset Printing and Publishing, Inc., an Iowa corporation organized under the Iowa Business Corporation Act, was held by informal action pursuant to §4996A.140 of the 1987 Code of Iowa, and the undersigned, Colleen K. Nicholl, constituting the only member of the Board of Directors and the only Shareholder of the corporation, adopted, and consented to the adoption of the following resolutions:
