The undersigned individual, acting as the incorporator of a corporation organized under the Iowa Business Corporation Act, Chapter 496A, Code of Iowa, as amended, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is KVI Agri-Services, Incorporated.

ARTICLE II

The corporation's existence shall commence on the date the Iowa Secretary of State issues a Certificate of Incorporation and the period of it's duration shall be perpetual.

ARTICLE III

The corporation shall have unlimited power to engage in and to do any lawful act concerning any and all lawful business for which corporations may be organized under this Act.

ARTICLE IV

The number of shares of which the corporation shall have authority to issue is One Million (1,000,000) shares, all of which shares shall be of one class of common stock and shall have a par value of One Dollar (\$1.00) each.
