AFFIDAVIT OF TAX PAYMENT

I, COZETTE HARRIS, being first duly sworn on oath depose and state that I am also known as COZETTE L. HARRIS and COZETTE LARELLE HARRIS and that these names refer to one and the same person, myself.

I further depose and state as follows:

1. That I know from personal knowledge that KENNETH LEE HARRIS was also known as KENNETH L. HARRIS and KENNETH HARRIS, and that these names refer to one and the same person.

2. That I was the duly appointed executor of the KENNETH LEE HARRIS ESTATE, which estate was probated in the Iowa District Court in and for Adair County as Probate Number 7267.

3. That on July 9, 1990, I did cause to be filed an Application for Order Nunc Pro Tunc explaining and correcting a typographical misdescription which appeared on the Schedule A - Continuation Sheet of the Probate Report and Inventory of the KENNETH LEE HARRIS ESTATE and on Page 2, Paragraph 10D of the Final Report in the KENNETH LEE HARRIS ESTATE. That on July 9, 1990 an Order was entered correcting the typographical misdescription as described in said Application Nunc Pro Tunc.

4. That on May 24, 1988, I did file with the Iowa Department of Revenue and Finance an Iowa Inheritance Tax Return for the KENNETH LEE HARRIS ESTATE. Said Inheritance Tax Return reported a total gross estate of \$398,051.27 and a net estate of \$110,627.00, resulting in no Inheritance Tax liability for myself, a certificate to this effect from the Iowa Department of Revenue is on file. That at the time of my

husband's death, the Iowa Inheritance Tax Statute provided a surviving spouse exemption equal to \$180,000.00.

5. That the above described Iowa Inheritance Tax Return for the KENNETH LEE HARRIS ESTATE did contain the typographical misdescription corrected in said Order Nunc Pro Tunc filed July 9, 1990, but that despite said typographical misdescription, the correct property, with respect to which this Affidavit is being filed, was fully appraised for Iowa Inheritance Tax purposes and all Iowa Inheritance Tax due thereon fully paid.

6. That I know from personal knowledge that there exists no addition within the Town of Earlham, Madison County, Iowa, known as Johnston or Johnston's Addition.

7. That this Affidavit is filed with respect to the following described real property located in Madison County, Iowa, to-wit:

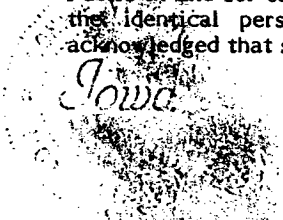
South One-half of Lot One (1) and all of Lot Two (2) in Block One (1) of Johnson's Addition to the Town of Earlham, Madison County, Iowa.
