ARTICLES OF INCORPORATION OF

The undersigned Incorporator of a corporation organized under the Iowa Business Corporation Act, Chapter 496A, Code of Iowa (1987), does hereby adopt the following Articles of Incorporation for such corporation.

ARTICLE I. NAME OF THE CORPORATION

The name of the corporation shall be Cleghorn & Sons Inc.

ARTICLE II. PURPOSES

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be organized under such Act.
