The corporation shall have unlimited power to engage in and to do any lawful act concerning any and all lawful business for which corporations may be organized under the Act.

ARTICLE IV.

The aggregate number of shares which the corporation shall have authority to issue is 100,000, all of which shall be common shares with a par value of one dollar (\$1.00) per share.

All stock issued shall be nonassessable and additional shares of authorized stock may from time to time be issued provided that it is first offered to the existing holders of common stock in proportion to their respective holdings.

ARTICLE V.

The address of the initial Registered Office of the

corporation is Rural Route One, Box 42A, Truro, Iowa 50257, and the name of its initial Registered Agent at such address is Diane L. Goering.

ARTICLE VI.

There shall be at least one and no more than ten Directors to conduct the business and affairs of the corporation. Until the annual meeting of shareholders, the following person shall serve as Director of the corporation.

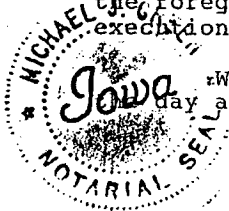
