DEED OF RELEASE

CRIST and GERALDINE CRIST, husband and wife, as joint tenants, all of the right, title and interest and every claim and demand whatsoever which said Trustee may now have or claim to have acquired in, under, through, or by virtue of said Indenture of Mortgage and Deed of Trust, as supplemented and amended, in and to the property situated in the County of Madison, and the State of Iowa, and described as follows, to wit:

That part of the Northeast Quarter of Section 11, Township 74 North, Range 27 West of the Fifth Principal Meridian, bounded as follows: On the Southwest by the Southerly extension of the center line of Florence Street; On the Northwest by a line parallel with and distant 150 feet Northwesterly, measured at right angles and radially, from the center line of the main track (now removed) of the Chicago, St. Paul and Kansas City Railway Company (later the Chicago Great Western Railway Company, now the Chicago and North Western Transportation Company), as said main track center line was originally located and established over and across said Section 11; On the Northeast by the Southerly line of County Road No. 307; And on the Southeast by a line parallel with and distant 50 feet Southeasterly, measured at right angles and radially, from the center line of the main track (now removed) of the Chicago and North Western Transportation Company (formerly the Chicago Great Western Railway Company), as said main track was located prior to its removal.

That part of the Northeast Quarter of Section 11, Township 74 North, Range 27 West of the Fifth Principal Meridian bounded as follows: On the West by the Southerly extension of the center line of Florence Street; On the Northwest by the Southeasterly line of the above described parcel of land; And on the Southeast by a line parallel with and distant 8.5 feet Southeasterly, measured at right angles and radially, from the center line of the most Southeasterly side track (now removed) of the Chicago and North Western Transportation Company (formerly the Chicago Great Western Railway Company), as said side track was located prior to its removal.
