

Amendment to Deed of Trust

This Amendment to Deed of Trust made this 22nd day of June, 1987 by and between Morford Farms Ltd. (hereinafter referred to individually and collectively as "Grantors") and Brenton Bank and Trust Co. (hereinafter referred to as "Grantee").

WHEREAS, Grantors have been, are now and may in the future become indebted to Grantee all as described in and secured by a Deed of Trust dated the 15th day of January, 1986 and recorded in the office of the Madison County Recorder in Volume 144 at page 756 (hereinafter referred to as "Said Deed of Trust") covering the following described real estate situated in the County of Madison, State of Iowa:

The Northwest Fractional Quarter of Section Eighteen Township Seventy-seven North, Range Twenty-nine West of the 5th P.M., Madison County, Iowa, and

The Southeast Quarter and the East Twenty-three acres of the South one hundred three acres of the Southwest Fractional Quarter of Section Thirty in Township Seventy-seven North, Range Twenty-nine West of the 5th P.M., Madison County, Iowa.

WHEREAS, Grantors and Grantee wish to amend Said Deed of Trust.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, it is agreed that Said Deed of Trust is hereby amended by adding thereto the following provision:

NOTICE: This mortgage (Deed of Trust) secures credit in the amount of \$ 485,000.00. Loans and advances up to this amount, together with interest, are senior to indebtedness to other creditors under subsequently recorded or filed mortgages and liens.

I UNDERSTAND THAT HOMESTEAD PROPERTY IS IN MANY CASES PROTECTED FROM THE CLAIMS OF CREDITORS AND EXEMPT FROM JUDICIAL SALE; AND THAT BY SIGNING THIS CONTRACT, I VOLUNTARILY GIVE UP MY RIGHT TO THIS PROTECTION FOR THIS PROPERTY WITH RESPECT TO CLAIMS BASED UPON THIS CONTRACT.

It is further agreed that all the terms and conditions of Said Deed of Trust shall remain in full force and effect.

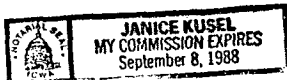
