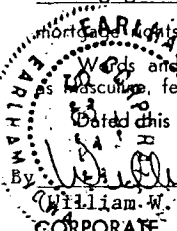

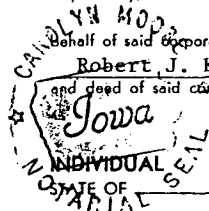

Commencing at the Southwest Corner (SW) of the intersection of Iowa Street and Chestnut Street in the City of Earlham, Madison County, Iowa, thence West along the South boundary of Iowa Street, 161 feet; thence South 135 feet; thence East 161 feet; thence North along the West boundary of Chestnut Street 135 feet to the point of beginning, Madison County, Iowa,
