

DESCRIPTION

A tract of land in the Northeast Quarter (1/4) of the Northeast Quarter (1/4) of Section Twenty—three (23) in Township Seventy—five (75) North, Range Twenty—six (26) West of the 5th P. M., Madison County, lowa, described as follows: Commencing at a point 198 feet East and 190 feet North of the Southeast corner of Lot Eight (8) in Block One (1) of Clanton's Addition of 1888 to the Town of St. Charles, lowa, running thence East 142 feet, thence North 115 feet, thence West 142 feet, thence South 115 feet to the point of beginning.

ALSO DESCRIBED AS FOLLOWS:

Commencing 340 feet East and 190 feet North of the Southeast corner of Block One (1) of Clanton's Addition of 1888 to the Town of St. Charles, in Madison County, lowa, and running thence West 76 feet, thence North 115 feet, thence East 76 feet, thence South 115 feet to the point of beginning, being a part of the Northeast Quarter of the Northeast Quarter of Section 23 in Township 75 North of Range 26, West of the 5th PM, except that part off the east side thereof, if any, occupied for street or highway purposes.

Also, a tract of land in the Northeast Quarter of the Northeast Quarter of Section 23, Township 75 North. Range 26, West of the 5th PM Madison County, lowa described as follows, to wit: Commencing at a point 198 feet East and 190 feet North of the Southeast corner of Lot Eight (8) in Block One (1) of Clanton's Addition to the Town of St. Charles , lowa, running thence East 66 feet, thence North 115 feet, thence West 66 feet, thence South 115 feet, to the place of beginning.

PARCEL A

That part of the Northeast Quarter of the Northeast Quarter of Section 23, Township 75 North, Range 26 West of the Fifth Principal Meridian, Madison County, lowa, described as follows:

Commencing at the Southeast Corner of Lot 8, Block 1, Clanton's Addition of 1888 to St. Charles, Iowa; thence on an assumed bearing of North 89 degrees 57 minutes 29 seconds East 198.00 feet; thence North 00 degrees 00 minutes 00 seconds East 250.38 feet to the point of beginning; thence North 00 degrees 00 minutes 00 seconds East 60.00 feet to the south line of Austin's Addition to St. Charles, lowa;

thence North 89 degrees 49 minutes 55 seconds East along said south line 142.00 feet; thence South 00 degrees 00 minutes 00 seconds West 60.00 feet; thence South 89 degrees 49 minutes 55 seconds West 142.00 feet to the point of beginning.

Said tract contains 8520.0 square feet and is subject to City Street right of way over the easterly 600.0 square feet thereof.

That part of the Northeast Quarter of the Northeast Quarter of Section 23, Township 75 North, Range 26 West of the Fifth Principal Meridian, Madison County, lowa, described as follows:

Commencing at the Southeast Corner of Lot 8, Block 1, Clanton's Addition of 1888 to St. Charles, lowa; thence on an assumed bearing of North 89 degrees 57 minutes 29 seconds East 198.00 feet; thence North 00 degrees 00 minutes 00 seconds East 190.00 feet to the point of beginning; thence North 00 degrees 00 minutes 00 seconds East 60.38 feet; thence North 89 degrees 49 minutes 55 seconds East 142.00 feet; thence South 00 degrees 00 minutes 00 seconds West 60.69 feet; thence South 89 degrees 57 minutes 29 seconds West 142.00 feet to the point of beginning.

Said tract contains 8595.8 square feet and is subject to City Street right of way over the easterly 606.8 square feet thereof.
