



DESCRIPTION- PARCEL 1

That part of the Southwest Quarter of Section 24, Township 75 North, Range 26 West of the Fifth Principal Meridian, Madison County, Iowa, described as follows:

Commencing at the southwest corner of the Southwest Quarter of said Section 24; thence on an assumed bearing of North 00 degrees 00 minutes 00 seconds East along the west line of said Southwest Quarter a distance of 1013.78 feet to the point of beginning;

thence continuing North 00 degrees 00 minutes 00 seconds East along said west line 200.00 feet;

thence North 90 degrees 00 minutes 00 seconds East 170.00 feet; thence South 00 degrees 00 minutes 00 seconds East 200.00 feet; thence North 90 degrees 00 minutes 00 seconds West 170.00 feet to the west line of the Southwest Quarter of said Section 24 and the point of beginning.
