

## DESCRIPTION- PARCEL L

A tract of land commencing at the Southwest corner of the Southeast Quarter (1/4) of the Northwest Quarter (1/4) of Section Twenty—four (24), Township Seventy—five North, Range 26 West of the 5th P.M., Madison County, Iowa, and running thence east 27 rods, thence North 53.6 rods, thence West 27 rods, thence South 53.6 rods to the place of beginning, except that part thereof conveyed to Madison County, Iowa, for highway.

thence on an assumed bearing of North 00 degrees 00 minutes 00 seconds East along the west line of said Southeast Quarter of the Northwest Quarter 181.78 feet to the southwesterly line of a City of St. Charles, lowa, street and the point of beginning; thence North 00 degrees 00 minutes 00 seconds East along said west line 702.62 feet; thence North 85 degrees 20 minutes 28 seconds East 445.50 feet; thence South 00 degrees 00 minutes 00 seconds East 884.40 feet to the south line of the Southeast Quarter of the Northwest Quarter of said Section 24; thence South 85 degrees 20 minutes 28 seconds West along said south line 321.93 feet to the southwesterly right of way line of a City of St. Charles, lowa, street; thence North 34 degrees 33 minutes 01 seconds West along said southwesterly line 164.28 feet;

thence North 39 degrees 24 minutes 24 seconds West along said southwesterly line 47.20 feet to the west line of said Southeast Quarter of the Northwest Quarter and the an the point of beginning.
