## AFFIDAVIT OF RELIANCE

Comes now William W. Hunter, who on oath deposes and states:

I am making this Affidavit in connection with the chain of title to the following described real estate, to-wit:

Forty (40) acres in the Northeast corner of the Northwest Quarter (NW1/4) of Section Six (6), Township Seventy-seven (77) North, Range Twentyeight (28) West of the 5<sup>th</sup> P.M., Madison County, Iowa, described as follows, to-wit: Commencing at the Northeast corner of the Northwest Quarter (NW1/4) of said Section Six (6), thence West 1198.87 feet, thence South 1448 feet, thence East 1208 feet, thence North 1448 feet to the place of beginning (also described as the North Forty (40) acres of the East Onehalf (E½) of the Northwest Fractional Quarter (NWfrl¼) of said Section Six(6)).

## **AND**

Part of the E½ NW¼ Sec. 6-77-28 described as follows: Commencing at a point 429 feet North of the SE corner of NW1/4 Sec. 6-77-28, thence N. 621.46 feet, thence W. 1208 feet, thence S. 613.75 feet, thence E. 600.77 feet, thence S. 33 feet, thence E. 610.5 feet to the place of beginning, conveys 17.15 acres.

Hunter Trust dated October 2, 1962 and Restated and Amended on October 24, 1975, pursuant to an instrument recorded on January 16, 1963 in Book 92, Page 44, in the Office of the Recorder of Madison County, Iowa. Robert E. Hunter was one of the income beneficiaries of the Ralph B. Hunter Trust. Robert E. Hunter died on October 15, 2010. The Ralph B. Hunter Trust terminated as a result of the death of Robert E. Hunter, and the above described real estate is being transferred and distributed to this affiant in accordance with the terms of the trust instrument and as part of the winding up and distribution of said trust.
