



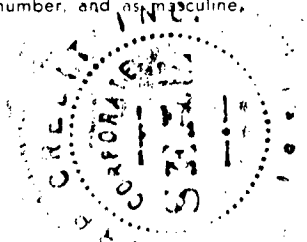
# RELEASE OF REAL ESTATE MORTGAGE
