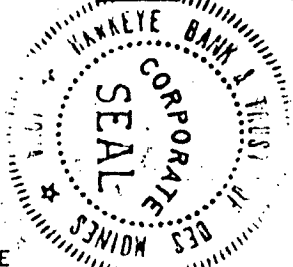


RELEASE OF DEED OF TRUST
