(Quinn & Dohrmann)DEED OF RELEASE

KNOW ALL MEN BY THESE PRESENTS, that THE FIRST NATIONAL BANK OF CHICAGO, a National Banking Association duly organized and existing under the laws of the United States of America (hereinafter referred to as the "Trustee"), as Trustee under Indenture of Mortgage and Deed of Trust dated as of January 1, 1939, between Chicago and North Western Railway Company, a corporation duly organized under the laws of the State of Wisconsin, and said The First National Bank of Chicago, as Supplemented and amended (Chicago and North Western Transportation Company, a Delaware corporation, being Successor Mortgagor), recorded in the office of the Recorder of Deeds in and for the County of Madison, in the State of Iowa, on April 9, 1970, in Book 113, at Page 271, as Document No. 479, and in Chattel Index as Financing Statement G-3196.

FOR AND IN CONSIDERATION of the payment of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, does hereby RELEASE, REMISE, CONVEY and QUITCLAIM unto JAMES W. QUINN and JOETTE J. DOHRMANN of 3408 Ashworth Road, West Des Moines, Iowa, 50265, GRANTEE, all of the right, title and interest and every claim and demand whatsoever which said Trustee may now have or claim to have acquired in, under, through, or by virtue of said Indenture of Mortgage and Deed of Trust, as supplemented and amended, in and to the property situated in the County of Madison, and the State of Iowa, and described as follows, to wit:

A strip of land 100 feet in width extending over and across the North Half of the Northeast Quarter of Section 36, Township 74 North, Range 28 West of the Fifth Principal Meridian, said strip of land being 50 feet in width on each side of the center line of the main track (now removed) of the Chicago, St. Paul and Kansas City Railway Company (later the Chicago and North Western Transportation Company), as said main track center line was originally located and established over and across said Section 36.

A strip of land 100 feet in width extending over and across the West Half of the Northwest Quarter and the Southeast Quarter of the Northwest Quarter of Section 31, Township 74 North, Range 27 West of the Fifth Principal Meridian, said strip of land being 50 feet in width on each side of the center line of the main track (now removed) of the Chicago, St. Paul and Kansas City Railway Company (later the Chicago Great Western Railway Company, now the Chicago and North Western Transportation Company), as said main track center line was originally located and established over and across said Section 31.

A strip of land 100 feet in width lying Northerly of and adjoining the above described 100-foot wide strip of land in the South Half of the Northwest Quarter of said Section 31, and lying Easterly of a line drawn at right angles to said original main track center line at a point thereon distant 850 feet Easterly of the intersection thereof with the West line of said Section 31.

A strip of land 100 feet in width lying Southerly of and adjoining the above described 100-foot wide strip of land in the South Half of the Northwest Quarter of said Section 31, and lying Easterly of a line drawn at right angles to said original main track center line at a point thereon distant 850 feet Easterly of the interction thereof with the West line of said Section 31.






