NOW on this _/3 day of _____, 1989, this matter coming on for hearing on the application of the Trustees in the above named matter, and the Court being fully advised in the premises finds that part of the duties of said Trustees are to sell, exchange, borrow, mortgage, lease, loan and otherwise dispose of assets, to release mortgages and liens, to invest and to do other acts with individuals, associations, partnerships, corporations and other types of institutions, which must rely on the acts of these Trustees.

The Court further finds that historically there has been a managing Trustee of the Trustees of the Thomas D. Gregg Fund and that since February 13, 1973, that has been James E. Van Werden.

The Court further finds that since that date he has made all of the investments after proper consultation with the other Trustees and with the Court when necessary, and has done all other acts on behalf of the Trustees of the Thomas D. Gregg Fund and has signed all necessary documents on behalf of said Trust.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that James E. Van Werden, one of the Trustees of the Thomas D. Gregg Fund, be, and he is hereby authorized and empowered to sell, exchange, borrow, mortgage, lease, loan and otherwise dispose of assets, to release mortgages and liens, to invest and to do other acts with individuals, associations, partnerships, corporations and other types of institutions, which must rely on the acts of these Trustees.
