Whereas, AUTEN is the record Title Holder to a 7.084 acre, more or less, parcel of ground, (referred to herein as "ACREAGE"), and legally described to wit:

Parcel A in the Northwest Fractional Quarter (NW Frac. 1/4) of the Northwest Quarter (NW1/4) of Section Seven (7), Township Seventy-six (76) North, Range Twenty-nine (29) West of the 5th P.M., also known as;

A parcel of land in the Northwest Fractional Quarter (NW Frac. 1/4) of the Northwest Quarter of Section Seven (7), Township Seventy-six (76) North, Range Twenty-nine (29) West of the 5th P.M., Madison County, Iowa, more particularly described as follows:

- 2. The parties further agree that in the event AUTEN maintains livestock of any type within ACREAGE, that AUTEN shall so modify and maintain the above described fence so as to properly restrain such livestock and pay any and all damage, to
