A parcel of land located in the Northwest Quarter of the Northeast Quarter, in the Southwest Quarter of the Northeast Quarter and in the Southeast Quarter of the Northwest Quarter, all in Section 23, Township 74 North, Range 28 West of the 5th Principal Meridian, Madison County, Iowa, more particularly described as follows:

Beginning at the Southwest Corner of the NW. $\frac{1}{4}$ of the NE. $\frac{1}{4}$ of Section 23, T74N, R28W of the 5th P.M., Madison County, Iowa; thence North 00°00'00" 440.00 feet; thence North 89°59'50" East 270.00 feet; thence South 00°00'00" 700.00 feet; thence South 89°59'50" West 600.00 feet; thence North 00°00'00" 260.00 feet to the North line of the SE. $\frac{1}{4}$ of the NW. $\frac{1}{4}$; thence, along said North line, North 89°59'50" East 330.00 feet to the Point of Beginning. Said parcel of land contains 6.308 acres, including 0.633 acres of county road right of way.

The West Half (1/2) of the Northeast Quarter (1/4) and the Southeast Quarter (1/4) of the Northwest Quarter (1/4) and the East Half (1/2) of the Southwest Quarter (1/4) of Section Twenty-three (23), except a tract commencing at the Southwest corner of the Northwest Quarter (1/4) of the Northeast Quarter (1/4) of said Section, running thence North 440 feet, thence East 270 feet, thence South 700 feet, thence West 600 feet, thence North 260 feet, thence East 330 feet to the point of beginning, and the Northeast Quarter (1/4) of the Northwest Quarter (NE 1/4) of Section Twenty-six (26), all in Township Seventy-four (74) North, Range Twenty-eight (28) West of the 5th P.M., Madison County, Iowa, except that part thereof deeded to State of Iowa for highway purposes.
