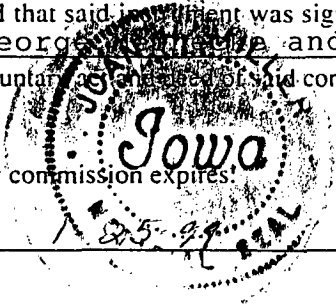

ADDENDUM "A"

The North Half ( $N\frac{1}{2}$ ) of the Northeast Quarter ( $NE\frac{1}{4}$ ); the North Half ( $N\frac{1}{2}$ ) of the Southwest Quarter ( $SW\frac{1}{4}$ ) and the Northwest Quarter ( $NW\frac{1}{4}$ ) of the Southeast Quarter ( $SE\frac{1}{4}$ ) except the East 20 feet of said last described forty acre tract used for a road and except the school house site in the Northeast corner thereof; all in Section Twenty-nine (29), in Township Seventy-seven (77) North, of Range Twenty-six (26) West of the 5th P.M.

Commencing at the Northeast Corner of the Northwest Quarter ( $NW\frac{1}{4}$ ) of the Southeast Quarter ( $SE\frac{1}{4}$ ) of Section Twenty-nine (29), Township Seventy-seven (77) North, Range Twenty-six (26), running thence South Twelve (12) rods, thence West Fourteen (14) rods, eight and one-half ( $8\frac{1}{2}$ ) feet, thence North Twelve (12) rods, thence East to the place of beginning, said site being more commonly known as subdistrict School No. Five (5).

The South Half ( $S\frac{1}{2}$ ) of the Northeast Quarter ( $NE\frac{1}{4}$ ) of Section Twenty-nine (29) in Township Seventy-seven (77) North, Range Twenty-six (26) West of the 5th P.M., Madison County, Iowa.

The South Half ( $S\frac{1}{2}$ ) of the Southwest Quarter ( $SW\frac{1}{4}$ ) of Section Twenty-nine (29) and the North Half ( $N\frac{1}{2}$ ) of the Northwest Quarter ( $NW\frac{1}{4}$ ) of the Northwest Quarter ( $NW\frac{1}{4}$ ) of Section Thirty-two (32), in Township Seventy-seven (77) North, Range Twenty-six (26) West of the 5th P.M., Madison County, Iowa,
