ASSIGNMENT OF MORTGAGE NOTE AND MORTGAGE

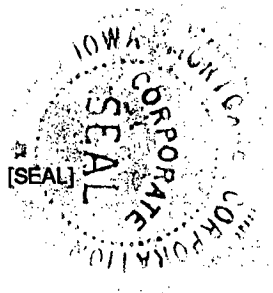

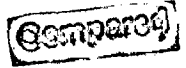
