

That part of Parcel C, recorded in Book 2007 Page 1566, of the Southwest Quarter of the Southeast Quarter of Section 6, Township 75 North, Range 29 West of the 5th P.M., Madison County, lowa, described as follows;

Commencing at the South Quarter corner of said Section 6; thence on an assumed bearing of South 89 degrees 11 minutes 15 seconds East, 507.67 feet along the south line of said Southwest Quarter of the Southeast Quarter; thence North 00 degrees 54 minutes 57 seconds West, 42.84 feet to the southwest corner of said Parcel C; thence North 00 degrees 54 minutes 57 seconds West, 325.22 feet along the west line of said Parcel C to the point of beginning; thence North 00 degrees 54 minutes 57 seconds West, 200.00 feet to the northwest corner of said Parcel C; thence North 89 degrees 58 minutes 50 seconds East, 423.77 feet to the northeast corner of said Parcel C; thence South 00 degrees 55 minutes 03 seconds East, 200.00 feet along the east line of said Parcel C; thence South 89 degrees 58 minutes 50 seconds West, 423.78 feet to the point of beginning, having an area of 1.95 acres.
