The undersigned, Scott F. Hockaday, hereby acknowledges payment in the sum of \$14,692.00 as full payment in satisfaction of an obligation arising as a part of the Decree of Dissolution in the above-entitled matter which states:

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the marital residence of the parties, locally known as 513 West Market Street, St. Charles, Iowa 50240, be and the same is hereby awarded to the Petitioner, subject to the promissory note and mortgage hereinafter granted to Respondent in the amount of Fourteen Thousand Six Hundred Ninety-two and 00/100 Dollars (\$14,692.00), plus interest at the rate of six percent (6%) per annum on the unpaid balance, commencing April 29, 1995.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the aforementioned six percent (6%) per annum interest be and the same is hereby, conditionally waived through April 29, 1996, provided Petitioner shall pay and satisfy the aforementioned promissory note on or before said date....

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Petitioner shall, and she is hereby offered to execute, within fourteen (14) days from the entry of this Decree, a promissory note payable to Respondent in the amount of Fourteen Thousand Six Hundred Ninety-two and 00/100 Dollars (\$14,692.00) plus interest at six percent (6%) per annum, commencing April 29, 1995,


