VOLUNTARY FORECLOSURE AGREEMENT

This Agreement is made on this <u>A</u> day of <u>My </u>, 2011, and entered into by and between Exchange State Bank (hereinafter "Bank") and Patrick A. Sargent and Amanda E. Sargent, Husband and Wife (hereinafter called "Borrower").

WHEREAS, the Borrower wishes to enter into an Agreement to grant the Bank a Deed in Lieu Foreclosure of the mortgage it has with the bank; and

WHEREAS, the Bank agrees to accept such Deed in Lieu of Foreclosure and agrees to waive any rights to a deficiency or other claim against the Borrower arising from that mortgage; and

IN CONSIDERATION of the mutual promises of the Parties and other valuable consideration exchanged, the Parties intending to be legally bound, hereby agree as follows:

- 1. **Deed in Lieu of Foreclosure.** The Borrower agrees to grant a Deed in Lieu of Foreclosure, of a certain mortgage held by the Bank, to the Bank in return for the Bank agreeing to waive any rights to a deficiency or other claim against the Borrower. This is a full settlement of this matter.
- 2. **Mortgage Specifics.** Said mortgage was dated February 28, 2007, and filed March 6, 2007, in Book 2007, Document No. 0630 of the Recorder's Office of Guthrie County, Iowa.
- 3. **Real Estate Involved.** The real estate covered by the mortgage is described as follows:

Unit No. Eleven (11) of Division Street Condominiums pursuant to Declaration of Submission of Property to Horizontal Property Regime, recorded October 11, 2005, in Book 2005, Doc. 3133 of the Guthrie County Recorder, located in Lots Seven (7), Eight (8), Nine (9) and Ten (10), Except the North 23 feet, all in Block Forty-six (46) of the Original Town of Stuart, Guthrie County, Iowa Unit No. Eleven (11) is also described as Unit L. Seller also conveys 8.45% of the undivided interest in the Common Areas and Facilities.

Said property is locally known as: 507 N. Division Unit 11, Stuart, IA 50250.

4. **Absolute Conveyance.** This Deed in Lieu of Foreclosure is being given as an absolute conveyance of the real estate described herein and is not being given as additional security.

- 5. **Immediate Access.** The Bank shall have immediate access to the real property for the purpose of maintaining and protecting the property. The Borrower shall have no further right, title or interest in the property.
- 6. **Entire Binding Agreement.** This Agreement is the entire agreement of the Parties and shall be binding on the Parties and inure to the benefit of their respective successors and assigns.
- 7. **State Law.** This Agreement shall be governed by and construed in accordance with the laws of the State of Iowa.
- 8. **Severability.** If any provision of this Agreement is deemed to be void, invalid, or unenforceable, the rest and remainder of the Agreement will remain in full force and effect.
