Five Hundred Twenty-four and NO/100Dollars on the same day of each month thereafter.
Said payments to be first applied to the balance of interest due at the rate of $\frac{11.00}{10.00}$
per cent per annum from November 2, , 19 90 and the remainder to the balance of principal until paid in full.
(2) That, not withstanding the foregoing provisions or anything to the contrary contained
in said mortgage, if the part ies of the second part shall be in default for more than
thirty days in making payment of any monthly installment, as herein provided then after
such default has occured, the party of the first part may hereby declare the balance then
unpaid on said mortgage due and payable forthwith, and may foreclose said mortgage in
accordance with the terms, conditions and provisions thereof.
