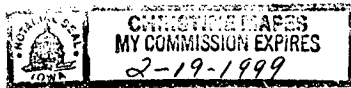

Parcel "A", located in the Southeast Quarter ( $\frac{1}{4}$ ) of the Northeast Quarter ( $\frac{1}{4}$ ) of Section Two (2), Township Seventy-six (76) North, Range Twenty-seven (27) West of the 5th P.M., Madison County, Iowa, more particularly described as follows: Commencing at the Southwest Corner of the Southeast Quarter ( $\frac{1}{4}$ ) of the Northeast Quarter ( $\frac{1}{4}$ ) of Section 2, Township 76 North, Range 27 West of the 5th P.M., Madison County, Iowa; thence North  $0^{\circ}47'44''$  West along the West line of the Southeast Quarter of the Northeast Quarter of said Section 2, 361.98 feet; thence North  $89^{\circ}12'16''$  East, 27.55 feet to the point of beginning which lies on the centerline of county road G-4-R; thence North  $43^{\circ}23'25''$  East along said road centerline 47.80 feet; thence Northeasterly 417.46 feet along a 2083.48 foot radius curve concave Northwesterly with a chord of North  $37^{\circ}39'01''$  East, 416.77 feet; thence South  $75^{\circ}42'34''$  East, 306.39 feet; thence South  $0^{\circ}00'00''$  West 247.17 feet; thence South  $85^{\circ}53'49''$  West, 585.83 feet to the point of beginning. Said parcel contains 3.061 acres, including 0.568 acres of county road right-of-way.
