

### RELEASE OF REAL ESTATE MORTGAGE

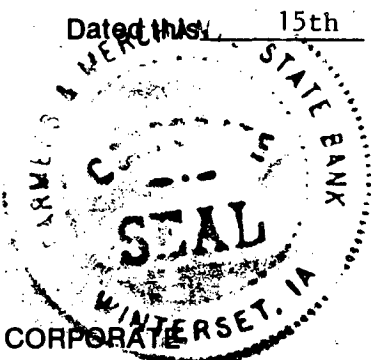
Know All Men by These Presents:

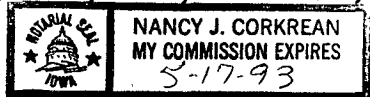
