## **ASSIGNMENT**

WHEREAS, United Federal Savings Bank of Iowa, Des Moines, Iowa also, formerly known as Ottumwa Savings & Loan, First Federal Savings & Loan of Rock Rapids, Sioux City Federal Savings & Loan of Sioux City, Jefferson Savings & Loan of Fairfield and Home Federal Savings & Loan of Sioux City, ("Bank") is a federally chartered savings association, the accounts of which are insured by the Federal Deposit Insurance Corporation ("FDIC");

WHEREAS, the RTC submitted an application to the Director to organize United Federal Savings Association of Iowa, Des Moines, Iowa, a new federal savings association to take over such assets or such liabilities as the RTC may determine to be appropriate;

WHEREAS, the Director has authorized the incorporation of United Federal Savings Association of Iowa, Des Moines, Iowa; and a federal charter therefor has been authorized and issued by the Office of Thrift Supervision;


