ORDINANCE NO. 1931

AN ORDINANCE AMENDING THE CITY CODE OF THE CITY OF WEST DES MOINES, IOWA, 2009 BY AMENDING CITY CODE, TTLE 9 (ZONING), CHAPTER 6 (COMMERCIAL, OFFICE AND INDUSTRIAL ZONING DISTRICT), SECTION 6 (COMMERCIAL, OFFICE, AND INDUSTRIAL USE REGULATIONS), TABLE 6.1 (USE MATRIX) TO ALLOW SIC 832 - SOCIAL SERVICES AND SIC 833 - JOB TRAINING AS PERMITTED USES IN THE PROFESSIONAL COMMERCE PARK (PCP) AND OFFICE (OF) ZONING DISTRICTS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WEST DES MOINES, IOWA:

Section 1. <u>AMENDMENT</u>. Amend Title 9, *Zoning*; Chapter 6 (Commercial, Office and Industrial Zoning District), Section 6 (Commercial, Office, and Industrial Use Regulations), Table 6.1 (Use Matrix) to allow uses SIC 832 – Social Services and SIC 833 – Job Training as Permitted (P) in the Office (OF) and Professional Commerce Park (PCP) zoning Districts and amend Table 6.1 as illustrated:

Section 2. Repealer. All ordinances or parts of ordinances in conflict with the provision of this ordinance are hereby repealed.

Section 3. <u>Savings Clause</u>. If any section, provision, sentences, clause, phrase or part of this Ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any provision, section, subsection, sentences, clause, phrase or part hereof not adjudged invalid or unconstitutional.

Section 4. <u>Violations and Penalties.</u> Any person who violates the provisions of this Ordinance upon conviction shall be punished as set forth in Section 1-4-1 of the City Code of the City of West Des Moines, Iowa.

Section 5. Other Remedies. In addition to the provisions set out in the Violations and Penalties Section herein, the City may proceed in law or equity against any person, firm or corporation for violation of any section or subsection of this Ordinance.

Section 6. Effective Date. This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.
