## SUBORDINATION AGREEMENT

THE SMALL BUSINESS ADMINISTRATION, an Agency of the United States Government, (hereinafter referred to as "SBA"), hereby represents that it is the owner and holder of a lien on certain real estate of <u>FARMERS COOPERATIVE</u>
