### AMENDMENT TO MORTGAGE

WHEREAS, on January 21, 1986, ROLLING HILLS FS, INC., Winterset, Iowa, as Mortgagor, executed and delivered to the NATIONAL BANK FOR COOPERATIVES (a/k/a CoBank) (successor in interest through merger of the Omaha Bank for Cooperatives, Central Bank for Cooperatives and various other district banks for cooperatives), as Mortgagee, a mortgage which was recorded on February 27, 1986, in Book 145, Page 27, of the Mortgage Records of Madison County, Iowa.

WHEREAS, this mortgage references a Loan Agreement dated the 21st January, 1986, and further references, in general, one or more Supplements to said Loan Agreement all of which have been entered into between the Mortgagor and the Mortgagee to evidence the lending arrangements which exist between said Mortgagor and Mortgagee.

WHEREAS, the Mortgagor and Mortgagee have entered into new Loan Document(s) of various dates, all being subsequent to the date of this Mortgage, which evidence the various loans currently outstanding between the Mortgagor and Mortgagee and which Loan Document(s) are in the format now being used to evidence all future loans that may be made and may be outstanding between the Mortgagor and Mortgagee.

WHEREAS, this Mortgage is intended by the Mortgagor and Mortgagee to serve as collateral for all past, current, and future loans, indebtedness, liabilities and obligations of every kind and nature which currently exist or may exist in the future between the Mortgagor and the Mortgagee.

NOW, THEREFORE, BE IT RESOLVED, that it is hereby agreed that this mortgage is hereby amended to delete the reference to a Loan Agreement dated January 21, 1986, and Supplements to said Loan Agreement and to now reference the fact that loans, indebtedness, liabilities and obligations now existing or hereinafter entered into between the Mortgagor and Mortgagee will be evidenced by the Loan Document(s) entered into between the Mortgagor and the Mortgagee as of a date subsequent to the date of this Mortgage which is set forth above.

BE IT FURTHER RESOLVED, that the Mortgagor and Mortgagee affirm that this Mortgage is to continue to serve as collateral for all past, current and future loans indebtedness, liabilities and obligations of every kind and nature which currently exist or may exist in the future between the Mortgagor and Mortgagee.

BE IT FURTHER RESOLVED, that this mortgage shall remain in full force and effect except insofar as changed by this Amendment, and shall continue as lien upon the property described therein.

IN WITNESS WHEREOF, the Mortgagor and the Mortgagee have executed this instrument on the date set opposite their signatures.

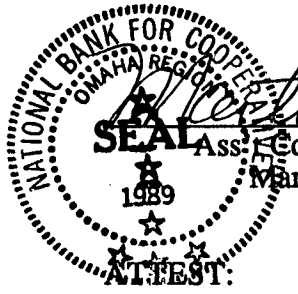

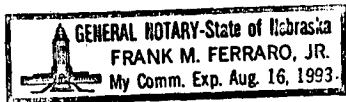
