

The North Half ($N\frac{1}{2}$) of the Southeast Quarter ($SE\frac{1}{4}$) of Section Twenty-five (25), Township Seventy-seven (77) North, Range Twenty-seven (27), West of the 5th P. M., Madison County, Iowa.

The South Half ($S\frac{1}{2}$) of the Northeast Quarter ($NE\frac{1}{4}$) except a tract commencing at the northwest corner thereof and running thence east 61 rods and 2 feet, thence Southwesterly to a point 71 rods south of the point of beginning, thence north 71 rods to the point of beginning, in Section Twenty-five (25), Township Seventy-seven (77) North, Range Twenty-seven (27), West of the 5th P. M., Madison County, Iowa, containing approximately 65 acres.
